Tanzania, in its final submissions March 23rd 2022, THRDC was able to make its submission in Geneva and Tanzania increased the number of accepted recommendations from 108 to 187.

Also the Coalition is collaborating with the Ministry of Constitutional and Legal Affairs (MOCLA) to finalize the National Human Rights Action Plan II (NHRAP II) which is yet to be finalized since 2018. Apart from that, the Coalition has continued engaging with development partners; the Parliament, Judiciary, the Government and other state apparatus for recognition of HRDs, reform and enactment of laws, frameworks, plans and policies related to HRDs.

THRDC continues to build capacities of the Human Rights Defenders so that they can better serve the society through the civil society sector. We are always striving to establish and maintain good will and mutual understanding with all our stakeholders. Through our various initiatives, we have been able to empower, protect, respect, recognize and reach out to many Human Rights Defenders in the country.

We are currently developing our 3rd strategic Plan, looking forward to engaging further and working together in the future for the well-being of the Human Rights Defenders in Tanzania.



COMMEMORATION OF THE 10TH ANNIVERSARY OF THE TANZANIA HUMAN RIGHTS DEFENDERS COALITION

This years, THRDC celebrated its 10th anniversary together with the Human Rights Defenders' Day on the 13th of May 2022. This year's theme is "10 years of THRDC: A foundation for recognition and protection of HRDs' Rights in Tanzania."

Recognizing the role played by the Coalition in promoting and protecting human rights in the country, **The President of United Republic of Tanzania H: E Samia Suluhu Hassan** officiated the commemoration of THRDC's 10th Anniversary being the first President in Africa to attend a Human Rights Defenders' event. The event was attended by several representatives from the Government authorities of both mainland and Zanzibar; 400 HRDs, regional and international human rights institutions including the President of African Court Lady Justice Imani Aboud; human rights organizations, judicial officers, National human rights institutions, lawyers, academicians, development partners, journalists, members of private sectors and experts of human rights.

Celebrating its 10th anniversary, THRDC took stock of the work of the Coalition for the past ten years including assessing the situation and the development of the work of HRDs in Tanzania. Also, this memorable day continues to emphasize strong relationship between HRDs and the government through building defenders'-friendly alliances and adopting concrete measures to promote and protect human rights actors in Tanzania.

President Samia breaks record as first sitting President to attend HRDs' events in Africa

It was an exciting moment on May 13, 2022, as THRDC marked its ten years with the President gracing the event. In her speech, the THRDC Board Chairperson retired Judge Honorable Joaquine De Mello gave an overview of the organization on how it began with 14 members and its growth to over 200 members stressing that it was indeed gratifying to celebrate the 10 years of THRDC with the first female President and an ardent advocate of human rights.

In her keynote speech, the President of the United Republic of Tanzania her excellence Samia Suluhu thanked the Coalition for the invitation adding.

"You have earned trust from the government, no wonder you have grown to this level. There is no institution that doesn't want human rights. We are very pleased to have people who can support us in protecting human rights. You still have so much to do, organize yourself, the government is there to support you," said the President

She used the occasion to remind all CSOs to ensure that they take heed of the Tanzanian context in terms of traditional customs and culture as they promote and protect human rights. The President reminded CSOs and especially THRDC to create public awareness on the Constitution to enable citizens to understand their rights and responsibilities.

Government urged to enact special law to protect Human Rights Defenders

The government of Tanzania has been called upon to enact a special law that will protect Human Rights Defenders. THRDC National Coordinator Advocate Onesmo Olengurumwa made the call in Dar es Salaam on May 13 while concluding his speech before the President of the URT her Excellency Samia Suluhu Hassan.

"We request a law or policy that recognizes Human Rights Defenders. We as Human Rights Defenders face, a lot of challenges and we have no legal protection. We face a lot of challenges including working permits, sometimes being branded as the opposition of the government and this has been restricting our work. In 2020, we faced a lot of challenges, one being freezing of our Bank accounts." said the National Coordinator.

Hassan Shire made a similar call, the Chairperson of Pan African Rights Human **Defenders** Network and Executive Director of Defend Defenders said we are supportive of the protection of human rights defenders and civic space. "I hope Tanzania will adopt a law to protect human rights defenders. The bill is a zero cost, but it will be legitimate because the law says human rights defenders are legitimate," he said.

THRDC National Coordinator, Advocate Onesmo Olengurumwa, said human rights defenders had prepared a special article on President Samia's contribution in the promotion of human rights.



President Samia launches a Situation Report on Human Rights Defenders and Civic Space in Tanzania 2021

Celebrating THRDC 10th anniversary will remain memorable to the Coalition. THRDC has been publishing Situation Report on Human Rights Defenders for the past ten years. This year, THRDC has published the ninth report detailing the

situation of Human Rights Defenders (HRDs) and Civic Space in Tanzania launched by the President of United Republic of Tanzania on the 13^{th of} May 2022. The report has six chapters examining laws and policies which provide for the recognition and protection of HRDs at the national, regional and international level; strategic cases, cases against HRDs and documents various incidents on violations committed against HRDs. The reports go further to analyze the situation of civic space of and CSOs in Tanzania based on the various indicators.

Sweden calls for open dialogue between State and the citizens

The Swedish envoy to Tanzania Madam Sandra Diesel has emphasized the need for the country to embark into an open dialogue between the State and citizens saying it is key if the gap between the State and its citizens is to be bridged.

The envoy made her remarks during the commemoration where among other things he observed that THRDC has recorded notable resilience over the years adding that its engagement in the UPR is recommendable as the government has accepted the highest recommendations in history.

MoCLA reiterates its commitment to maintaining collaboration with THRDC

The Ministry of Constitution and LegalAffairs (MoCLA) has reiterated its commitment to receive THRDC's work plan and to see how they can incorporate it in the government plan. MoCLA Permanent Secretary Mary Makondo made the commitment during her opening remarks during the 10 years commemoration since the inception of the THRDC. She



commended the organization for its five years plan on human rights, urging it to ensure that human rights reach all the way to rural areas. On another note, the Permanent Secretary applauded the latter for a commendable job on the Universal Periodic Review saying for the first time, the country had taken heed of 187 recommendations that involved various groups inclusive of human rights defenders.

"The government has taken heed over the need to protect Human Rights Defenders. The Ministry of Constitutional and Legal Affairs will continue working with the Coalition to enhance human rights promotion and protection to serve our people. We, have been working together in universal periodic review process, we are currently working together to finalize the second National Human Rights Action and we will continue supporting your initiatives." said Makondo.

THRDC CONTINUES TO MONITOR UPR IMPLEMENTATION PROGRESS IN TANZANIA

The Universal Periodical Review (UPR) is a State-driven process which involves a review of the human rights records of all UN Member States. The ultimate aim of the mechanism is to improve human rights in all countries and address human rights violations. As an umbrella organization, THRDC in collaboration with partners continues monitoring and documenting the implementation progress of recommendations.


The third UPR session for Tanzania was held on November 5th 2021. In preparation for the session, THRDC collaborated with the Legal and Human Rights Center (LHRC), and Save the Children to coordinate development of a joint CSO submission to the November session. Prior to the actual session, THRDC hosted an in-country presession on October 5th 2021. The pre-session provided CSO representatives with an opportunity to engage delegates from 13 embassies based in Dar es Salaam.

On November 5, 2021, the UN human rights council hosted the actual UPR 3rd Cycle for the United Republic of Tanzania in Geneva Switzerland. At the session, Tanzania received a total of 252 recommendations from various member states. A draft UPR Working Group report issued on 09th November 2021 revealed that out of a total of 252 recommendations received, Tanzania accepted 108 (43%), deferred 12 (4.8%), and noted/rejected 132 (52%). The number of accepted recommendations decreased from 70% in 2011, 58% in 2016 to 43% in 2021.

Nevertheless, the Tanzania was then given opportunity to further review the recommendations for a final reply. This provided CSOs with opportunity to push for the government's acceptance of more recommendations.

In November 2021, THRDC facilitated a UPR in-country post-session meeting which was held in Dar es Salaam. The meeting brought together 37 civil society representatives from across the Coalition's nine zonal divisions. The meeting reviewed the recommendations particularly those noted and rejected and came up with a list of grounds as to why the government should consider accepting more recommendations. The list was then submitted to the Ministry of Constitutional and Legal Affairs for consideration.

This year, 2022, THRDC continued to monitor UPR recommendation progress to the government of Tanzania as one of the human rights mechanism and advocacy strategy to improve human rights situation in the country.

On March 23 2022, a final UPR session on the United Republic of Tanzania took place in Geneva Switzerland. At the session, Tanzania gave its final position regarding the recommendations. This time there was a positive development whereby the country increased the number of accepted recommendations from 108 to 187 (20 being partially accepted), while noted recommendations decreased from 132 to 65. Accepted recommendations included recommendations on freedom of expression.

"We have accepted all recommendations to amend of the Media Service Act of 2016 and other laws in order to enhance freedom of expression and right to information. Efforts to further promote protection of right to information, includes reinstating of 9 Televisions which had been suspended as well as reduction of their registrations fees. Further, newspapers licenses which have been revoked they have been re-issued regarding that they will comply with country media laws" Hon. George Simbachawene

Adv. Onesmo Olengurumwa, the THRDC National Coordinator was able to participate in this session with support of and in collaboration with Defend Defenders. Adv. Olengurumwa delivered a submission at the session.

Post Session Stakeholders Working Group Meeting for Developing a CSO UPR Recommendations Implementation Action Plan.

In April 2022, THRDC collaborated with the Legal and Human Rights Center to hold a two day working group meeting for developing a civil society action plan for the implementation of the final accepted UPR recommendations. The two-day meeting was held in Morogoro and brought together representatives from 45 CSOs, the Ministry of Constitutional and Legal Affairs and the Commission for Human Rights and Good Governance

The working group meeting reviewed the UPR session outcome report and its addendum. This was followed by filling the CSOs UPR Recommendations Implementation Plan Matrix on areas of: identifying accepted, partially accepted, and noted recommendations; identifying regional/international mechanisms which have given similar recommendations, as well as corresponding SDGs.

On April 12 2022, THRDC hosted a stakeholders' meeting for validation of the CSO UPR Recommendations Action Plan. The meeting brought together representatives from 120 CSOs, Government officials from Tanzania mainland and Zanzibar including the Registrar of NGOs (Zanzibar), Registrar of NGOs (Mainland), Commission of Human Rights and Good Governance, Director of Good Governance (Zanzibar), and Director of Human Rights (Mainland). The meeting was officiated by Hon. Damas Ndumbaro, Minister of Constitutional and Legal Affairs.

THRDC TEAMS UP WITH MINISTRY OF CONSTITUTION AND LEGAL AFFIARS TO FINALISE NATIONAL HUMAN RIGHTS ACTION PLAN

Following the resolution passed by an engagement meeting with the Ministry of Constitutional and Legal Affairs (MOCLA) to collaborate in finalizing the National Human Rights Action Plan II (NHRAP II) on 30th ?March 2022; THRDC in collaboration with Ministry conducted the Civil Society Organization (CSOs) consultation meeting on the National Human Rights Action Plan as an opportunity for the consultative committee of the proposed Plan to present before stakeholders for feedback and recommendations. This shapes the plan reflecting on overarching needs and priorities of majority of people in Tanzania Mainland and Zanzibar.

THRDC continues to collaborate with relevant stakeholders including the ministry, other state apparatus and the Commission for Human Rights and Good Governance (CHRAGG) to enhance human rights promotion and protection in the country. NHRAPII sets a platform for a comprehensive approach for human rights promotion and protection. It demonstrates Tanzania's commitment to its international human rights obligations and the desire of the Government to improve the respect, protection, and fulfilment of human rights in Tanzania.



The ministry in collaboration with other stakeholders has incorporated the UPR recommendations and Five Years National Development Plan III (FYNDPIII) and consultative meeting the CSOs adds value to the plan to make it comprehensive. This activity was carried on 10th May 2022 with an objective to make the necessary inputs into the draft National Human Rights Action Plan (NHRAP 2022-2027) reflecting on overarching needs and priorities of majority of people in Tanzania Mainland and Zanzibar in line with the Five Years National Development Plan III.

DIALOGUE ON HRDS PROTECTION: "AN INCLINATION OF HUMAN RIGHTS DEFENDERS PROTECTION FOR THE PAST 10 YEARS"

As part of commemoration of the Coalition 10th Anniversary, THRDC organized a dialogue on issues affecting human rights promotion and protection in Tanzania titled: "An Inclination of Human Rights Defenders Protection for the past 10" held on 11th May 2022.

This grounded defenders day message and recommendations to set an agenda and vision for the future. The dialogue provided an opportunity to celebrate how, the dignity of human rights defenders has been uplifted, human suffering prevented and the foundations for a more secure environment for HRDs put in place.

The dialogue took a stock development of human rights defenders (HRDs) rights in Tanzania, discussing challenges affecting HRDs in the country. It gave an opportunity to a thematic discussion on interactions between the government and civil society & human rights defenders, based on concrete and practical experience from 10 years of THRDC operation. This grounded THRDC recommendations to relevant stakeholders in human rights promotion and protection.

THRDC TRAINS 50 HUMAN RIGHTS ORGANISATIONS ON INTERNATIONAL NORMS AND BEST PRACTICES IN NGO REGULATION IN ZANZIBAR

THRDC-Zanzibar with support from the International Center for Not-for-Profit Law (ICNL) conducted a two days training session on 15th & 16th March 2022 for 50 Zanzibar CSO representatives as part of efforts to expand civic space for their sustainable operations. In the session participants were trained on issues including: human rights monitoring, reporting and documentation; international norms and best practices on civic space protection; as well as challenges facing civic space in Zanzibar. Following the topics participants identified priority areas for advocacy and developed a strategic plan with specific actions for widening civic space in Zanzibar.

Following the civic space training conducted in March 2022, THRDC hosted a follow-up meeting on **May 26th 2022** in Zanzibar. The meeting brought together 16 (10 men and 6 women) CSO representatives from Unguja and Pemba aimed at discussing the action plan, gathering updates on implementation of the actions, adding more CSOs to commit to implementing the actions, and agreeing on implementation follow-up mechanism. The positive response from the participants shows promising implementation of the action plan. The Coalition will continue colaborating with other stakeholder to widen civic space in the isles to an enabling environment of CSOs operation.

IWD 2022: THRDC STEALS THE SHOW AS IT MARKS IWD WITH ACCOLADES TO FEMALE RIGHTS ACTIVIST

Every year on 8th March the world marks the International Women's Day where women's social, economic, cultural and political achievements are celebrated globally.

Like in other parts of the world, gender inequality underpins many problems which disproportionately affect women & girls including women HRDs. Despite of all these challenges, Tanzania has had prominent women who have influenced change at various level in the community. These veteran WHRDs did not only defend women's rights but also, saw the need to promote and defend human rights in general. Celebrating IWD2022, THRDC organized a dinner gala on March 8 in Dar es Salaam to reflect the journey of WHRDs in the field of human rights by taking stock of what they did to make Tanzania where it stands today in the area of human rights. The event brought together about 45 prominent women HRDs in Tanzania and invited development partners.

Throughout the Dinner Gala, Dr. Hellen Kijo Bisimba, Justa Mwaituka, Jamila Juma and Dr. Mary Rusimbi, inspired women HRDs where they shared their own past experiences with each revealing untold stories of their journeys towards defending human rights. Their stories equipped women HRDs with the right skills and knowledge on how to navigate challenges in their work, but also served as motivation for pursuing human rights defending with zeal and vigor.

THRDC used this platform to recognize and award Dr. Hellen Kijo Bisimba as relentless and dedicated human rights defender. In her speech during the ceremony, THRDC Board Chairperson and retired Justice Joaquin De Mello, paid tribute to THRDC for the award saying "People should never wait for someone to die before they honor them for their good job".



In an immediate rejoinder, Dr. Bissimba said it was quite an honor to receive the award while calling upon rights defenders to speak without fear and in unison saying doing so would leave them safe unlike speaking in isolation.

In her opening remarks Miss Sandra Rossiter the Counsellor of Political, Economic and Public Affairs section at the Embassy of Canada made the commitment during the dinner Gala as part of the commemoration of the International Women's Day conducted by the Coalition.

"We recognize all human rights defenders who protect human rights all over the world and the organizations they represent. We recognize the need for civic space and an enabling safe environment for human rights defenders and protecting them from harm. It is our conviction that all human rights defenders have the rights to freedom of expression, of assembly," said Rossiter.

She said Canada is aware that women human rights defenders may be targeted for or exposed to specific violence including online and digital content for instance social media and ICT platforms. She continued;



"There are higher risks of sexual and gender based violence and intimidation. Women human rights defenders may be subjected to gender stereotypes stigmatized faith based groups, families and communities who consider their jobs threatening. I admire those who work as human rights defenders and women who work in that area and especially to honor Dr. Bisimba," she said Sandra

THRDC CONTINUES TO ENGAGE WITH GOVERNMENT AND OTHER STATE APPARATUS FOR RECOGNITION OF HRDS, REFORM AND ENACTMENT OF LAWS, FRAMEWORKS, PLANS AND POLICIES RELATED TO HRDS.

THRDC continues to engage government with the Parliament, Judiciary, the Government and other state apparatus for recognition of HRDs, reform and enactment of laws, frameworks, plans and policies related to HRDs. The first six months of 2022, the Coalition has conducted several strategic meeting with the government to influence policy and legal reform with the aim of improving the HRDs working environment to both Tanzania mainland and Zanzibar to enhance the country's human rights promotion and protection.

a. THRDC Strives to Strengthen Working Relationship with the Ministry of Constitutional and Legal Affairs

THRDC conducted an engagement meeting with the Ministry of Constitutional and Legal Affairs (MOCLA) scheduled 07th March 2022 following the appointment of new Minister Hon. George Simbachawene. The Coalition was pleased to be introduced to the ministry's new leadership of and deliberate key areas of collaboration to push forward development agenda. For the period of 10 years since its inception, the Coalition has been working with the Ministry of Constitutional and Legal Affairs (MoCLA) in various matters defending and protecting HRDs. Amongst the resolution passed by this strategic meeting was to finalize the National Human Rights Action Plan (NHRAPII), collaboration in monitoring and implementation of the Universal Periodic Review and improving working environment of HRDs in the country.



In September 2021, Tanzania Human Rights Defenders Coalition (THRDC) registered its Branch in Zanzibar. This follows several initiatives taken by THRDC to improve the working environment of Human Rights defenders (HRDs) across Tanzania since its establishment in 2012.

It should be noted that, the operating context of Human Rights Defenders in Zanzibar differs to some extent with that of Tanzania Mainland. This due to the fact that Zanzibar has its own laws and policies that govern the operation of CSOs in Zanzibar. Also the level of understanding among HRDs, Government officials and the general public on issues affecting HRDs might be different compared to the Tanzania mainland

Through various initiatives, THRDC have been able to empower, protect, respect, recognize and reach out to many Human Rights Defenders including Judges and Magistrates of the Judiciary of Zanzibar. The coalition has continued to engage the Revolutionary Government of Zanzibar in making some changes to human rights defense, with the view to improve and strengthen the performance of human rights organization.

LITIGATION, EMERGENCY SUPPORT AND RESCUE

Protection of Human Rights Defenders is the core objective that the Tanzania Human Rights Defenders Coalition envisions. To realize this core goal, the Coalition through its protection department provides several protection services and support to HRDs at risk such as legal, medical, short-term relocation, family support to the survivors/HRDs at risk and security measures.

Between January and June 2022, a total of sixty (55) human rights defenders were supported with relocation, medical, legal support, and other emergency support. Families at risk, individual HRDs, journalists, indigenous land human rights defenders. Further, fact finding missions and trial observations were conducted by the Coalition.

Overall Achievements: Litigation, Emergency Support and Rescue

LITIGATION

- 55 HRDs have been provided with legal and other emergency support
- Two cases against HRDs were withdrawn by the Director of Public Prosecutions as he had no interest to prosecute such cases more. Such HRDs were set free by the court, and they immediately resumed their role of promoting and protecting human rights in Tanzania.

EMERGENCY SUPPORT &RESCUE

- Relocation support offered to the HRDs, no further risks were experienced by them during and after the lapse of relocation period
- Health condition for HRDs supported with medical support improved, although they have not vet actively resumed their role of defending human rights. One HRD has resumed her role of defending human rights. Continuous documentation of HRDs incidents.

OVERALL CHALLENGES

- HRDs and journalists were maliciously obstructed from doing their job.
- Unlawful arrest, detention and threats to HRDs i.e Ngorongoro district
- Some HRDs at risk don't react on security incidents on time hence making protection interventions complicated.
- Delay of cases against HRDs as the investigation take too long to be completed and if not completed, the republic tends to withdraw the case.
- Restrictive law on Public interest cases.

MEMBERS'AFFAIRSANDPUBLIC ENGAGEMENT

Providing technical support including physical visitations to zonal coordinating units

While building a strong CSOs movement that serves to protect HRDs and human rights in Tanzania, THRDC provides technical support to more than 200 of its members and mobilizes them. To achieve this objective, the Coalition conducts periodic physical visits to the offices of its member organizations. From February 10th to 25th June 2022, THRDC's Head of Programs Mr. Remmy Lema and Head of Members Affairs Department, Public Relations Officer Miss. Lisa Kagaruki, visited seventeenth (17) members of the coalition in the Western Zone (Katavi, Tabora and Kigoma). Physical visitation to members has been intending to bring together the Coalition and its members by understanding their organization, document their key successes and lessons, challenges faced at zonal level, identify areas for empowerment and recommend for the better and more professional working environment, Advocating the coalition's work in the region for the HRDs that are not aware of it and recruiting new human rights organizations who are interested in becoming members of THRDC.

Conduct a Survey on Institutional and Organizational Capacity Development to THRDC Members

THRDC as an umbrella organization has the obligation of ensuring member organizations' capacity is improved through various interventions. Under this reporting period, THRDC engaged a consultant to conduct a survey on organizational management capacity to members. The objective of this activity was to review the Organization's managerial capacities of the selected THRDC member and empower them on the same. The activity was conducted in some of the Coalition's zones including Southern Coast Zone, Western Zone, Eastern Lake Zone, Southern Highland, East Coast Zone, Central Zone, Northern Zone Unguja and Pemba Zone

The survey was conducted to 21 members to assess the organizational management capacity and all selected members were supported to develop their SPs.
