(ZANGOF 2022)

### Dear Esteemed Readers

Welcome to our special newsletter of Zanzibar Non-Government Organization Forum (ZANGOF) of 2022 organized by the Office of NGO-Registrar-Zanzibar in collaboration with Association of Non - Governmental organization of Zanzibar (ANGOZA) which took place from 12th to 15th March at Golden Tulip Hotel grounds, Zanzibar.



This year theme was

### "strengthening NGOs and Government partnership for development of Zanzibar".

Recognizing the importance of this Forum, THRDC participated and facilitated the participation of about 25 civil society organization from both Unguja and Pemba. ZANGOF 2022, was an opportunity for these organizations to improve its relationship with the government and increase networking among themselves and other stakeholders.

For THRDC, this was a significant event regarding the establishment of THRDC-Zanzibar Office in 2021. The Coalition is effectively collaborating with the government of Zanzibar to improve working environment of Human Rights Defenders (HRDs). Recently, the coalition has signed a Memorandum of Understanding with Judiciary to collaborate in improving access to justice.

Apart from the Judiciary, THRDC also works closely with the Commission for Human Rights and Good governance (CHRAGG), Police, Ministry of State, President Office, Legal Affairs, Public Service and Good Governance. Currently, THRDC in collaboration with the Judiciary of Zanzibar are conducting a need assessment to improve access to justice in Zanzibar.

ZANGOF 2022, brought together about 250 organizations in the country to discuss NGOs role and contribution to development. The forum also gave an opening to a thematic discussion on interactions between the government and civil society based on concrete and practical experience from non-governmental organizations including human rights defenders.

This position paper analyses effects and proposed possible mitigation strategies for all key sectors (informal sector, education, health, trade, agriculture, pastoralism, fishery, extractive industry and economy generally); and, gender groups (women, indigenous, remainders, prisoners, youth, children, refugees, people living with HIV, person with disabilities and elderly).

This position paper was disseminated to THRDC members and non-members to identify key strategic areas where this organization can invest in fighting COVID 19. The Civil Society Sector is complementing government efforts in fighting COVID 19 through; civic education to create awareness; provision of preventive materials; and working in health sector to improve health care.

## The definition of charitable organization need widen to include CSOs

One of the challenge discussed in ZNGOF 2022 was NGO being taxed as corporate organisations. Non-profit organisations are paying corporate tax arising from members' subscription fees, donations and grants at 30% on Annual Taxable Income. Conversely, there charitable organization are not taxed as corporate organisations. Yet, there are bureaucracies in grating an NGO

with a charitable status because most of Civil Society Organisation are non-profit working for development communities. But, the definition of charitable organisation covers religions institution only.

There is a need of widening the definition of charitable organization by aligning it with that of NGOs law. It should also be clear to the tax authorities that, any amount of money received by a CSO as project fund is not expected to generate profit.

Therefore, any legislation or provision or practice which charges CSOs taxes on basis of generating profit should be amended.
